This Memorandum of Understanding (MoU) is entered into on this 10 day of 02 month, 2023 year, by and between Veena Memorial College of Education, Padewa, Karauli, hereinafter referred to as "VMCE", and Shri Shyam Adarsh Public Secondary School Padewa, Karauli, hereinafter referred to as "SSAPSS, Padewa". Collectively, VMCE and SSAPSS, Padewa shall be referred to as the "Parties."

Preamble:

Recognizing the mutual benefits of collaboration between a teacher education institution and a primary school, the Parties intend to collaborate to enhance the learning experiences of both student-teachers and primary school students.

Key Areas of Collaboration:

1. Faculty and Student Exchange and Educational Support:

VMCE and SSAPSS, Padewa agree to facilitate the exchange of faculty members, student-teachers, and educational resources. This collaboration will involve providing educational support to SSAPSS, Padewa, including workshops, training programs, and mentoring for teachers, as well as practical teaching experience for VMCE's student-teachers. The Parties will establish a framework for this exchange, including the duration of the programs and the responsibilities of each party.

2. Collaboration in Extension, Curricular, and Extra-Curricular Activities:

VMCE and SSAPSS, Padewa will collaborate to organize joint extension activities, curriculum development initiatives, and extra-curricular events for the benefit of both institutions. This collaboration may include joint workshops, cultural events, and community outreach programs aimed at enriching the learning experience of both VMCE's student-teachers and SSAPSS, Padewa students.

3. Experiential Learning for the Student-teachers of B.Ed. Programs:

The Parties agree to provide experiential learning opportunities for the student-teachers of VMCE's B.Ed. and D.El.Ed. programs at SSAPSS, Padewa. This will involve practical teaching experiences, lesson planning, and classroom management under the guidance of experienced teachers at SSAPSS, Padewa. VMCE and SSAPSS, Padewa will work together to ensure that these experiences contribute to the professional development of the student-teachers and enhance the quality of education at GPS.

General Terms and Conditions:

1. Both Parties shall appoint designated coordinators responsible for overseeing the implementation of this MoU and facilitating communication between the institutions.
2. The duration of this MoU shall be for a period of 05 years, with the possibility of extension upon mutual agreement.
3. Any financial obligations arising from the collaborative activities shall be determined through separate agreements as needed.
4. Both institutions shall respect each other's autonomy and academic freedom.

Termination:

Either Party may terminate this MoU by providing a written notice of __ months to the other Party. The termination shall not affect ongoing collaborative activities, which shall be completed as agreed upon.

This MoU sets forth the understanding and intent of the Parties with respect to their collaboration. It is subject to the laws of the respective jurisdiction of each Party.
